### Bill Summaries

#### H2234: FIREARM; DEFINITION

Modifies the statutory definition of "firearm" to exclude weapons manufactured before January 1, 1899, weapons that may readily be converted to expel a projectile by expanding gases, and firearms that are incapable of being fired without mechanical repair by the use of tools or the replacement of parts, instead of excluding firearms in permanently inoperable condition.

#### H2551: FINANCIAL INSTITUTION RECORDS; DISCLOSURE; NOTICE

Financial institutions are prohibited from releasing or disclosing any financial record to any government authority unless the customer gives written consent, the financial institution has been served a subpoena, or the government authority has a search warrant for the specific record. Some exceptions. Establishes regulations for obtaining a subpoena or search warrant for financial records.
