AN ACT

AMENDING SECTIONS 28-857, 28-928 AND 28-930, ARIZONA REVISED STATUTES;
RELATING TO SCHOOL BUSES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 28-857, Arizona Revised Statutes, is amended to
3 read:

4 28-857. School bus signs; overtaking and passing school bus;
5 violation; driver license suspension; civil penalty

6 A. On meeting or overtaking from either direction a school bus that
7 has stopped on the highway, the driver of a vehicle on a highway shall:

8 1. Stop the vehicle before reaching the school bus, if the school bus
9 is displaying the signal as provided in subsection D OF THIS SECTION and if
10 alternately flashing lights are in use.

11 2. Not proceed until the school bus resumes motion or the signal and
12 alternately flashing lights are no longer displayed.

13 B. A bus used for the transportation of school children shall have on
14 the front and rear of the bus a plainly visible sign containing the words
15 "school bus" in letters not less than eight inches in height.

16 C. A school bus operated on a highway shall cover or conceal all
17 markings indicating "school bus" unless the bus is operated for the
18 transportation of children to or from any of the following:

- 19 1. School.
- 20 2. School sponsored academic activities.
- 21 3. School sponsored vocational and ~~technological~~ TECHNICAL education.
- 22 4. School sponsored athletic trips.
- 23 5. School sponsored extracurricular activities.

24 D. A bus used for the transportation of school children shall have a
25 signal with the word "stop" printed on both sides in white letters not less
26 than five inches high on a red background. The signal shall be an eighteen
27 inch reflectorized octagon. The operator of the school bus shall:

28 1. Manually operate the signal in a manner so that the signal is
29 clearly visible from both front and rear when extended from the left of the
30 body of the bus.

31 2. Display the signal and alternately flashing lights if passengers *stop*
32 are being received or discharged while the bus is stopped on ^{the} ~~the~~ roadway, ^{or} ~~OR~~ A
33 "PRIVATE ROAD OR DRIVEWAY." *= as defined term in 28-001.18.*

34 E. The driver of a vehicle on a highway with separate roadways need
35 not stop on meeting or passing a school bus that is:

- 36 1. On a different roadway.
- 37 2. On a controlled access highway and the school bus is stopped in a
38 loading zone that is a part of or adjacent to the highway and where
39 pedestrians are not permitted to cross the roadway.

40 F. For the purposes of subsection E OF THIS SECTION, a lane or group
41 of lanes on either side of a two-way left turn lane is not considered a
42 separate roadway.

43 G. A person who is responsible for a violation of subsection A of this
44 section is subject to a civil penalty as follows:

1 1. The court shall impose a minimum civil penalty of two hundred fifty
2 dollars for the first violation.

3 2. If a person violates this section a second time within a period of
4 thirty-six months, the court shall impose a minimum civil penalty of seven
5 hundred fifty dollars and shall direct the department to suspend the driver
6 license of the person for not more than six months.

7 3. If a person violates this section three or more times within a
8 period of thirty-six months, the court shall impose a minimum civil penalty
9 of one thousand dollars and shall direct the department to suspend the driver
10 license of the person for at least six months but not more than one year.

11 Sec. 2. Section 28-928, Arizona Revised Statutes, is amended to read:

12 28-928. Applicability of lighting laws

13 The sections of this article, including sections 28-929 through 28-934,
14 relating to clearance and marker lamps, reflectors and stoplights, apply as
15 stated in those sections to vehicles of the type enumerated in ~~the~~ THOSE
16 sections, namely passenger buses, trucks, truck tractors and certain
17 trailers, semitrailers and pole trailers, respectively, when operated on a
18 highway; EXCEPT THAT THE REQUIREMENTS OF SECTION 28-930 ALSO APPLY WHEN THESE
19 VEHICLES ARE OPERATED ON PRIVATE PROPERTY. These vehicles shall be equipped
20 as required and all lamp equipment required shall be lighted at the times
21 ~~mentioned~~ SPECIFIED in section 28-922, except that clearance and side marker
22 lamps need not be lighted on a vehicle when operated within any municipality
23 where there is sufficient light to render clearly discernible persons and
24 vehicles on the highway at a distance of five hundred feet.

25 Sec. 3. Section 28-930, Arizona Revised Statutes, is amended to read:

26 28-930. School bus lighting equipment; standards and
27 specifications

28 A. The director may adopt standards and specifications applicable to
29 lighting equipment on and special warning devices to be carried by school
30 buses consistent with and supplemental to this article. The standards and
31 specifications may designate and permit the use of alternately flashing
32 warning signal lights on school buses for the purpose of indicating when
33 children are boarding or alighting from a school bus. The standards and
34 specifications shall correlate with and, as far as possible, conform to the
35 current specifications as approved by the society of automotive engineers.

36 B. A person shall operate an alternately flashing warning signal light
37 on any school bus when the school bus is a minimum of one hundred feet from a
38 stop or is stopped ~~on a highway~~ for the purpose of permitting school children
39 to board or alight from it.

40 C. A school bus may be equipped with alternately flashing red strobe
41 lamps on the octagonal signal manually operated by the school bus operator
42 pursuant to section 28-857, subsection D.
